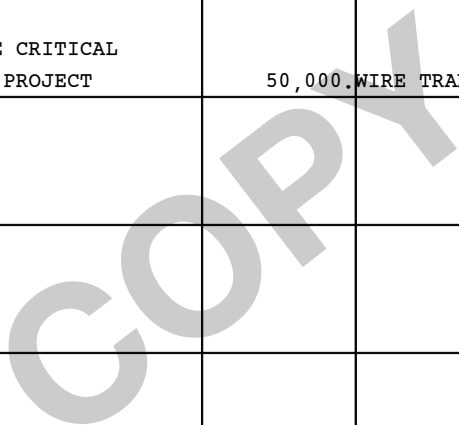
BUILDING RENTAL INCOME - NET

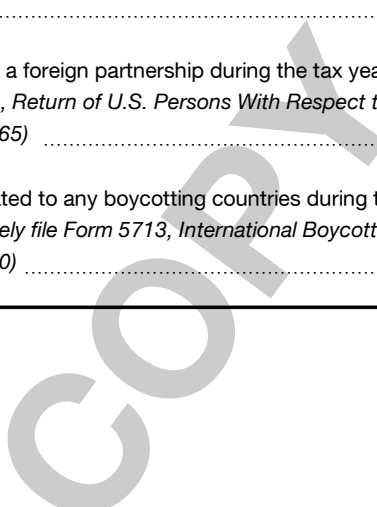

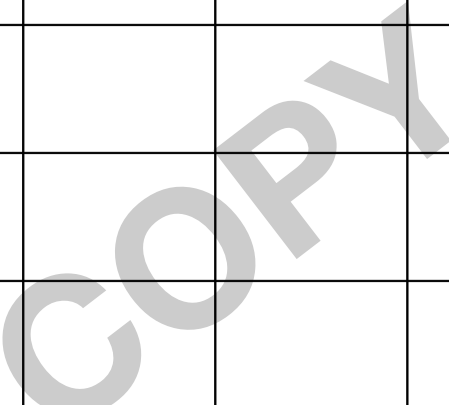
